In the event of swallowed: Not make vomit, maintain the patient at rest. Resort to the medical care.

Soiled clothing: withdraw soiled clothing and re-use them only after decontamination.

7. HANDLING AND STORAGE

7.1. Precautions for safe handling

Advice on safe handling: Avoid excessive inhalation of concentrated vapors. Follow good manufacturing practices for housekeeping and personal hygiene.
